### ORD #180910-1:ORD *First Reading* <u>ADOPTION OF AMENDMENT TO CHARTER ORDINANCE, & AMENDMENT TO</u> <u>CHAPTER 19.01(2) RELATING TO MUNICIPAL JUDGE TERM OF OFFICE</u>

### PART I. ADOPTION OF AMENDMENT TO CHARTER ORDINANCE

WHEREAS, on April 20, 2016, the Wisconsin Department of Administration Secretary issued a Certificate of Incorporation, legally establishing and recognizing the Village of Fox Crossing as an incorporated municipality in the State of Wisconsin; and

WHEREAS, the Village adopted a Charter Ordinance on April 25, 2016, and said Charter Ordinance became effective on June 25, 2016, when no petition for referendum was received by the Village Clerk within 60 days from publication. A copy of said Charter Ordinance is attached hereto as Exhibit A; and

WHEREAS, Wisconsin Statute 755.02 provides authority for cities and villages to alter the elected term of their Municipal Judge to a term not exceeding four (4) years, nor less than two (2) years, through the municipality's charter ordinance; and

WHEREAS, Wisconsin Statute 66.0101(1m) provides for the amendment of previously adopted charter ordinances.

NOW, THEREFORE, pursuant to Wis. Stats. §66.0101, and other applicable laws, the Village Board of the Village of Fox Crossing, Winnebago County, Wisconsin does hereby amend its Charter Ordinance to add the following provisions concerning the term of office for municipal judges:

### 2.01 MUNICIPAL JUDGE

<u>Term of Office.</u> The Municipal Judge shall be elected at large in odd years at the spring election for a term of two (2) years beginning in the 2019 spring election, with said term commencing on May 1 following his/her election.

This Amended Charter Ordinance shall take effect sixty (60) days after its passage and publication in the manner provided by Wis. Stats. § 66.0101.

Except as specifically amended hereby, all provisions of the existing Charter Ordinance remain effective.

# PART II. AMENDMENT TO MUNICIPAL CODE CHAPTER 19.01(2); MUNICIPAL JUDGE AND COURT

NOW, THEREFORE, the Village Board of the Village of Fox Crossing, Winnebago County, Wisconsin does hereby ordain that Chapter 19.01(2) shall be amended as follows:

**19.01(2) Election; Term.** The Municipal Judge shall be elected at large in odd years at the spring election for a term of four (4) two (2) years, or until a successor is elected and qualifies, beginning

in the 2019 spring election, with said term commencing on May 1<sup>st</sup> next succeeding his/her election. A permanent vacancy in the office of Municipal Judge may be filled in accordance with Wisconsin Statute sec. 8.50 as hereafter amended.

This ordinance amendment shall take effect upon the day the Amended Charter Ordinance takes effect.

### RES #180910-1 <u>APPROVE INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF</u> <u>APPLETON, CITY OF MENASHA, AND THE VILLAGE OF FOX CROSSING FOR</u> <u>RECONSTRUCTION AND URBANIZATION OF VALLEY ROAD FROM CHAIN DRIVE</u> <u>TO FORESTVIEW COURT</u>

WHEREAS, the City of Appleton, City of Menasha, and the Village of Fox Crossing desire to reconstruct and urbanize the portion of Valley Road located between Chain Drive and Forestview Court; and

- Concrete pavement 48 feet wide from back of curb to back of curb, with one through lane in each direction and a two way left turn lane.
- Five (5) foot sidewalk on both sides of the street.
- Five and one half (5.5) foot bike lanes on both sides of the street with two (2) foot buffers; and

WHEREAS, the underground utility work would be conducted in 2020, and the pavement reconstruction occurring in 2021; and

WHEREAS, the City of Appleton will serve as the lead agency for the street reconstruction portion of the project, with each individual community conducting the applicable utility work; and

WHEREAS, cost share for the project is based on frontage within each municipal boundary:
