# ORD #190812-1:ORD First Reading, Second Reading & Adoption AMEND FOX CROSSING MUNICIPAL CODE CHAPTER 7.02 DISCHARGE OF FIREARMS AND OTHER DANGEROUS WEAPONS; HUNTING, EXHIBIT B

The Village Board of Trustees of the Village of Fox Crossing do ordain as follows:

**Section 1.** Chapter 7.02 has been amended as follows:

WHEREAS, on October 22, 2018, the Village of Fox Crossing Board of Trustees amended Ordinance 7.02 concerning "Discharge of Firearms and Other Dangerous Weapons; Hunting," to protect the public health and safety of Village of Fox Crossing residents (ordinance #190812-1:ORD); and

WHEREAS, the Department of Natural Resources (DNR) has since recommended amending Exhibit B of Chapter 7.02, to make a minor modification to the map identifying prohibited areas of firearm discharge south of Stroebe Island, in order to improve the balance between hunters' rights and the safety of Village residents; and

WHEREAS, the Village Board of Trustees finds that the DNR proposed modification to Exhibit B would improve the balance between hunters' rights and the safety of Village residents.



# RESOLUTION PROVIDING FOR THE SALE OF \$3,980,000 GENERAL OBLIGATION CORPORATE PURPOSE BONDS

WHEREAS, the Village Board of the Village of Fox Crossing, Winnebago County, Wisconsin (the "Village") has adopted initial resolutions (the "Initial Resolutions") authorizing the issuance of general obligation bonds for the following public purposes and in the following amounts:

\$1,990,000 to finance street improvement projects;

\$200,000 to finance parks and public grounds projects;

\$1,460,000 to finance sewerage projects, consisting of storm sewer improvements;

\$145,000 to finance water system improvements; and

\$185,000 to finance projects in Tax Incremental District No. 3.

NOW, THEREFORE, BE IT RESOLVED that:

<u>Section 1. Combination of Issues.</u> The issues referred to in the preamble hereof are hereby combined into one issue of bonds designated "General Obligation Corporate Purpose Bonds" (the "Bonds"). The Village shall issue the Bonds in an amount not to exceed \$3,980,000 for the purposes above specified.

<u>Section 2. Sale of Bonds.</u> The Village Board hereby authorizes and directs that the Bonds be offered for public sale. At a subsequent meeting, the Village Board shall consider such bids for the Bonds as may have been received and take action thereon.

Section 3. Notice of Bond Sale. The Village Clerk be and hereby is directed to cause notice of the sale of the Bonds to be disseminated in such manner and at such times as the Village Clerk may determine and to cause copies of a complete, official Notice of Bond Sale and other pertinent data to be forwarded to interested bidders as the Village Clerk may determine.

Section 4. Official Statement. The Village Clerk (in consultation with Robert W. Baird & Co. Incorporated) shall cause an Official Statement concerning this issue to be prepared and distributed. The appropriate Village officials shall determine when the Official Statement is final for purposes of Securities and Exchange Commission Rule 15c2-12 and shall certify said Statement, such certification to constitute full authorization of such Statement under this resolution.

WHEREAS, the Village of Fox Crossing, Winnebago County, Wisconsin (the "Village") is presently in need of approximately \$3,845,000 for the public purpose of financing additions, improvements and extensions to the Village's Waterworks System and Sewerage System; and

WHEREAS, it is desirable to borrow said funds through the issuance of Waterworks System and Sewerage System Revenue Bonds pursuant to Section 66.0621, Wis. Stats.
