# PRELIMINARY ASSESSMENT RESOLUTION DECLARING INTENT TO EXERCISE SPECIAL ASSESSMENTS FOR THE INSTALLATION OF WATER MAINS AND LATERALS FOR THE CLAYTON AVENUE WATER EXTENSION PROJECT

A preliminary assessment resolution declaring intent to exercise special assessment powers under Chapter 66.0703 of the WI Statutes.

BE IT RESOLVED by the Board of Trustees of the Village of Fox Crossing, located in Winnebago County, Wisconsin, as follows:

- That the Village Board of Trustees hereby declares its intent pursuant to Chapter 66.0703 of the WI Statutes to levy special assessments upon property within the following described area for improvements upon said property. (*Exhibit A attached*).
  - a) DESCRIPTION OF SPECIAL ASSESSMENT PROJECT:
    Work shall consist of construction of 1,626 lineal feet of new water main and laterals to certain properties located along Clayton Avenue.
  - b) AREA OF SPECIAL ASSESSMENT IMPROVEMENTS:
     Clayton Avenue from East Shady Lane south to the south lot line of 9189
     Clayton Avenue. Refer to Exhibit A attached.
- 2) Said improvements shall include the required cost of construction and installation, including contract costs, engineering fees, attorney fees and publication expenses of the municipality.
- The Village Board of Trustees shall hereby determine that all such municipal improvements shall be made under Chapter 66.0703 of the WI Statutes and that the amount to be assessed against each affected parcel is based upon a reasonable basis being total construction and material cost including engineering fees, attorney's fees, publication expenses and other appropriated special assessment proceeding costs. The Village Board of Trustees further determines that all said improvements specially benefit the property described in Paragraph 1 above.
- 4) The assessments against affected property owner(s) may be paid in cash or in the number of installments to be determined at the Public Hearing on the proposed assessments and according to the final resolution of the Village Board of Trustees of the Village of Fox Crossing as may be hereinafter adopted.
- 5) The Village Engineers are directed to prepare an Engineer's Report consisting of:
  - a) <u>Preliminary</u> estimates for the entire cost of the proposed construction and installation, including cost of construction, material, engineering fees, attorney fees, publication expenses and other appropriate cost of special assessment proceedings.

- b) A schedule of proposed assessments against affected property prepared
- c) The Engineer's Report shall state that all such assessments are based upon a reasonable basis being total construction and material costs and that all said special assessments benefit the property(s) being assessed.

under the term and conditions of Chapter 66.0703 of the WI Statutes.

Upon completing said Engineer's Report the Village Engineers are directed to file a copy of the same in the office of the Village Clerk for public inspection.

6) Upon receiving the Engineer's Report of said Village Engineers, the Village Clerk is directed to prepare and publish a Class One Notice of a Public Hearing on said Engineer's Report and upon the Preliminary Special Assessment Resolution as specified in Chapter 66.0703 of the WI Statutes which Notice of Public Hearing shall state the place and time at which the report may be inspected and the place and time at which all persons interested or their agents or attorneys may appear before the Village Board for the Village of Fox Crossing and be heard concerning the matters contained in the Special Assessment preliminary resolution and the Village Engineers' Report at the Public Hearing. A copy of the Notice of Public Hearing together with a scale map (*if available*) showing the general boundary areas of the proposed assessment district/area shall be mailed at least ten (10) days before the hearing date to all interested persons whose post office addresses are known. The Public Hearing shall commence no less than ten (10) days, nor more than forty (40) days after publication. A Public Hearing shall be held in the Arden Tews Assembly Room at the Village of Fox Crossing Municipal Complex, 2000 Municipal Drive, Neenah, WI 54956, Winnebago County, State of WI, on the 28th day of February, 2022 at 6:00 p.m., or shortly thereafter, during the regularly scheduled Village Board Meeting.

## <u>A RESOLUTION IN SUPPORT OF IMPROVING THE INTERSECTION AT STATE</u> HIGHWAY 76 AND LARSEN ROAD

WHEREAS, in 2020, the Neenah Joint School District purchased 225 acres of land east of Clayton Avenue between CTH II and Larsen Road; and

WHEREAS, in 2020, the Neenah Joint School District received community support through a referendum to construct a new high school on this 225-acres of land; and

WHEREAS, the new Neenah High School is scheduled to open in the Fall of 2023 and will increase traffic at the intersection of State Highway 76 and Larsen Road; and

WHEREAS, in December of 2021, the Village of Fox Crossing received a letter dated December 2, 2021 from citizens regarding their concerns for the safety of the intersection at State Highway 76 and Larsen Road; and

WHEREAS, State Highway 76 has been undergoing improvements in Winnebago County to include reconstruction and intersection improvements at CTH GG, CTH G and CTH JJ.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of Trustees of the Village of Fox Crossing, Winnebago County, that we support the State of Wisconsin Department of Transportation and Winnebago County Highway Commission and Board of Supervisors to allocate sufficient funds for implementation of alterations to the intersection of State Highway 76 and Larsen Road in a timely manner meet the demands for and coincide with the opening of the new Neenah High School in the Fall of 2023.

BE IT FURTHER RESOLVED, that the Village Board directs the Village Clerk to deliver this approved resolution to State, County, City of Neenah, Town of Neenah, Town of Clayton, Town of Vinland and Neenah Joint School District Officials and to the individuals that signed the letter dated December 2, 2021, Max Ogden and Rustin Keller.
